Why This Is Important To You

- Your neighbor on *[Redacted]* recently had their water pipe repaired.*

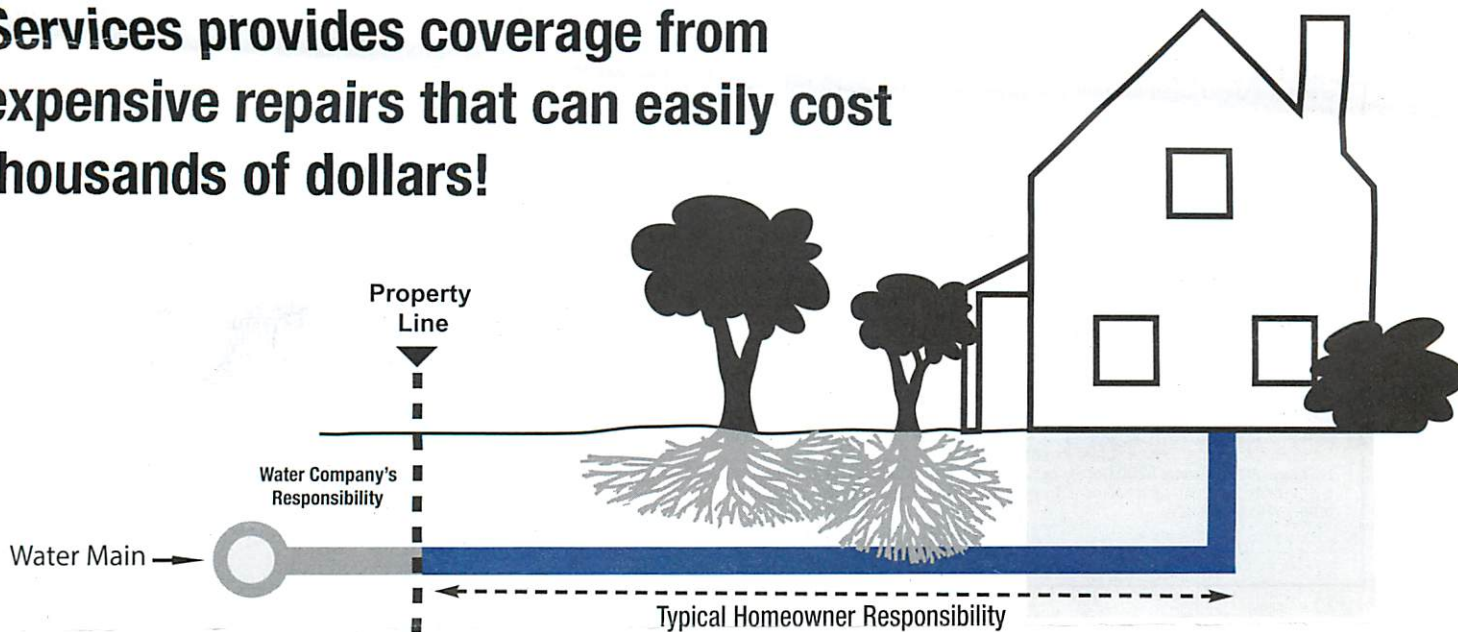
